# 18<sup>TH</sup> ANNUAL GENERAL MEETING HELD IN DHARAMSALA

The Tibetan Chamber of Commerce (TCC) held its 18th Annual General Meeting on 8 September 2025 at the Tibetan Community Hall in Dharamsala, attended by board members, entrepreneurs, and member and non-member. Hon. Sikyong Penpa Tsering, the chief guest, emphasized the importance of legal compliance, timely tax obligations, and financial responsibility for all institutions and entrepreneurs. He highlighted the need for organizational self-reliance within the Tibetan community. ## India begins detailed mapping of global trade rules to boost export compliance.



India's DGFT has launched a comprehensive mapping of global non-tariff measures faced by Indian exporters to create a centralized compliance database. Part of the Export Promotion Mission, the initiative aims to proactively address trade barriers and improve clarity on certification, testing, labelling, and inspection requirements. Exporters and trade bodies have been asked to submit relevant information within a week, or risk exclusion of sector-specific NTMs from the database.

## India's central bank expected to cut rates to 5.25% on December 5: Reuters poll.



RBI Expected to Cut Rates to 5.25% Next Week: The Reserve Bank of India is widely expected to lower its key repo rate from 5.50% to 5.25% at its December 5 policy meeting, according to a Reuters poll of economists. The anticipated cut comes as inflation drops to a multi-year low, giving the central bank room to support growth even as the rupee weakens and global trade pressures persist.
